## Executive Office on Early Learning

### **Report to the 2020 Legislature: December 24, 2019**

#### **History**

The Executive Office on Early Learning (EOEL) was established by Act 178, Regular Session of 2012, and signed into law in June 2012. On July 1, 2015, EOEL was transferred from the Office of the Governor to become attached to HIDOE for administrative purposes only.

EOEL is charged with developing an early learning system that shall ensure a spectrum of high-quality, developmentally appropriate early learning opportunities for Hawaii's children throughout the state, from prenatal care until the time they enter kindergarten.

Act 122, Session Laws of Hawaii 2014, appropriated \$3 million for the establishment of Hawaii's first State-funded pre-kindergarten program as a part of that system. EOEL launched the EOEL Public Prekindergarten Program (Program), through a partnership with the Hawaii Department of Education (HIDOE), at 18 department schools and 20 classrooms across the state starting the 2014-15 school year. The Program was statutorily established by Act 109, Regular Session of 2015.

#### **Context**

The EOEL Public Prekindergarten Program currently consists of 44 classrooms at 36 department and charter schools. Among these classrooms are those that were required to be incorporated into the Program as a result of Act 276, Session Laws of Hawaii 2019:

- Charter school prekindergarten classrooms that were previously funded through the federal Preschool Development Grant;
- Weighted student formula-funded prekindergarten classroom; and
- Prekindergarten classrooms for children to provide general education settings for children whose individualized education programs require such placement.

Ten new classrooms are also scheduled to open in the 2020-21 school year with funding provided through Act 276, bringing the total to 54 classrooms at 46 schools.

Act 276 also placed private partnership-funded classrooms in the public schools under the administrative authority of EOEL.

The subsequent tables address the following information with respect to the Program as of December 24, 2019:

- 1. The number and location of classrooms;**
- 2. Numbers of students served and aggregated by birth month as of the date on which the official enrollment count is taken;**
- 3. Sources of funding for each classroom;**
- 4. Quality of teacher-child interactions relating to social emotional support, classroom structure, and quality of learning experiences, as assessed using a formative assessment tool selected by the office; and**
- 5. Child outcomes relating to all areas of childhood development and learning, including cognitive, linguistic, social, and emotional approaches to learning and health and physical development, as assessed using a formative assessment tool selected by the office.**

Please note that this report provides information on all of these areas in regards to the EOEL Public Prekindergarten Program in the department schools, for School Year 2018-2019. The charter school classrooms and private partnership-funded classrooms in the public schools had not yet been put under the administrative authority of EOEL during that school year.

We have also included information on some of these areas for the current School Year 2019-2020. Because we are only mid-way through this school year, we do not yet have information for all of the areas that would allow for the most comprehensive picture possible.
